### SUMMARY OF AUDITOR'S MEETING WITH VFD CHIEFS' MEETING

FEBRUARY 27, 2020

#### BACKGROUND

The minutes from the June 15, 2015 meeting of Commissioners' Court require non-profit organizations that receive funds from the county to provide an annual report detailing income and expenses.

The minutes from the May 9, 2016 meeting of Commissioners' Court direct that the monthly payments to VFDs continue even if the monthly run reports have not been received and further directs the auditor to inform commissioners' court if any of the monthly reports are late.

#### RESEARCH AND FINDINGS

Financial statements were not on file for most of non-profit organizations. James Webster, as directed by Judge Lee, contacted the organizations and requested the financial statements. Most organizations have started sending in their reports. The VFDs had expressed questions to Chief McRae concerning the information needed to meet the requirements for financial statements.

As of March 4, all VFDs with the one exception of Cookville, have turned in their monthly run reports. Most VFDs turn in the monthly run reports monthly with a one month to six week lag. Cookville turned in their run reports for June 2019 through December 2019 on January 2, 2020.

#### CURRENT ACTIVITIES

I attended the Monthly Fire Chiefs' Meeting on February 27 at the invitation of Chief Larry McRae in effort to get updated contact information for each VFD, to remind them of the requirements for monthly run reports, and to explain what was needed for the financial statements. All VFDs were represented except for Cookville. As of March 4, Sugar Hill has turned in the annual report for 2019 while Argo has turned in a financial report for the month of December only. This week, I have also met with representatives of the Argo and Nortex VFD to assist them in determining the various methods available for them to follow in developing their annual detailed reports. Ms. Penny Ward, wife of Tri-Lakes Fire Chief, contacted me with similar questions and is now working on a financial statement. I also sent an email to Wesley McCollum and left a phone message for Isabel Smith who are representatives of the Cookville VFD. Ms. Smith contacted me and plans to have the annual report turned in within about two weeks.

Once the records are received, they will be on file in the auditor's office for your use as needed.
